TRI-COUNTY REGIONAL PLANNING COMMISSION CELEBRATES 60 YEARS AS A REGIONAL RESOURCE

For 60 years, the Tri-County Regional Planning Commission (TCRPC) has assisted the Tri-County Region of Ingham, Clinton, and Eaton counties and the City of Lansing in securing billions of dollars of federal funds for public infrastructure-particularly roads and transit. TCRPC has enabled formal, regional cooperation among the Region's county and municipal governments on infrastructure development, environmental protection, and land use planning since 1956. TCRPC shares current data on transportation systems and land use that developers use to attract and retain business investment; it implements programs to protect our region's surface and ground waters; and it helps our region's municipalities to identify and implement best land use management processes that encourage sustainable development.

TCRPC CELEBRATES 60 YEARS

TCRPC programs continue to foster intergovernmental cooperation as shown through the partnerships of the Greater Lansing Regional Committee for Stormwater Management (GLRC). TCRPC has supported the GLRC since its formation in 2003. In 2015, TCRPC hosted more than 120 meetings, engaging more than 2,500 people. TCRPC supports many regional projects and provides valuable data and information for planning and program implementation. TCRPC generated the 2040 Regional Transportation Plan in 2015 and just updated the 2017-2020 Transportation Improvement Program that secures over \$413 million in federal funds for the Region.

Since Clinton, Ingham, and Eaton counties founded the TCRPC in 1956, TCRPC has planned on and planned for regional collaboration that assists communities. It helps communities and agencies align with each other to achieve common goals. TCRPC works to implement a long-term vision for a sustainable, resilient, and prosperous regional community, with the dedication of Commissioners, the commitment of its members, and the expertise of its staff.
