No table coverings, table skirting, or signs are provided. If additional tables are required please indicate on your application. Additional tables are \$10 each. Booth location will be assigned according to date received.
- (2) Electricity (110v) is available on a limited, first come first serve basis. Please mark on your application if you require electricity.
- (3) All businesses are required to have completed set-up by 11 a.m. Festival hours are 12-6 p.m.
- (4) All businesses are required to remain set-up until the end of the festival.
- (5) Spaces are available on a first come first serve basis. All spaces must be paid in full at the time of reservation, including any additional tables.
- (6) No refunds. Festival takes place rain or shine.
- (7) Failure to comply with these terms and conditions will be treated as a breach of this agreement.
- (8) Delta Rocks! shall receive full indemnification. Remedy shall only be appropriate as application fee.
