Delta Township is creating a hiring list for part-time EMT/Firefighters or Paramedic/Firefighters. Applicants should be able to work 24-hour shifts and a minimum of 2,084 hours per year (approximately 7 shifts per month) for regular part-time, or at least 48 hours per month for contingent part-time.

Detailed qualifications are available at <http://www.deltami.gov/index.php/management/human-resources/> and include at a minimum: HS Diploma/GED, at least 18 years old, valid Michigan driver's license, and a clean criminal record. Both Full-time and Part-time positions require State of Michigan EMT or Paramedic licensure, FF I & II, BCLS, and Haz-Mat Operations. **Certificates must be submitted with application. Applicants that have passed FF I & II classes and at least EMT classes and are waiting to sit for State exams may be allowed to test, at the discretion of the Fire Chief.**

You **MUST** complete a Delta Township application <http://www.deltami.gov/wp-content/uploads/2012/09/Employment-Application.pdf>, and successfully complete required written and practical testing to be considered for a position. The written test may be scheduled for these positions, by going to the web site <https://www.empco.net/fts/> and following the instructions. There is a \$75.00 non-refundable fee to take the written examination. You must pass the EMPCO test by March 3, 2017 to be eligible for further testing for this application period.

Eligible candidates will be contacted the week of March 6, 2017 to schedule skills and physical agility testing (LPAT).

As a part-time EMT/Firefighter or Paramedic/Firefighter with Delta Township, this position is under the supervision of the Shift Captain serving when on-duty for assigned shifts or call responses. Responsibilities include responding to all emergency medical calls and fire calls as assigned. Must have knowledge and ability to operate all emergency medical and fire equipment of the Fire Department. All rules mandated by the Michigan Department of Health and Tri-County Protocols along with Fire Department Standard Operating Procedures must be observed.
