_____ **Cancellations and Reschedules**

(Initial) The minimum rental deposit is only refundable if the cancellation or reschedule is made prior to 14 days before the scheduled rental date. Date changes less than 14 days prior will be considered a cancellation.

POOL RULES AND REGULATIONS

It will be necessary for all groups to control their event and abide by the following rules. A representative of Delta Township and Waverly Schools will have access to the pool at all times. All pool policy rules are applicable to everyone in attendance at the event.

1. Staff reserves the right to postpone event if it is determined that pool is unsafe due to severe weather, bio hazard, etc.
2. No selling of products is permitted on site.
3. No tents or other pieces of equipment may be set up outside the school.
4. No glass bottles permitted on the pool deck.
5. No alcohol or drugs permitted.
6. Contact person must be present at the entire party and will be responsible for the conduct of their guests and any damage incurred by them.
7. Renter accepts liability for any destruction or defacement to any part of the building, pool facility, or equipment.
8. No gum chewing.
9. All participants must wear swimsuits. T-shirts are permitted over the top of a swimsuit, but no cut off jeans.
10. All swimmers must take a swim test to swim in the deep end. The lifeguard on duty will determine if one may swim in the deep end.
11. Children not fully potty trained must wear a swim diaper.
12. Children not at least 42" tall must be accompanied by an adult in the pool.
13. No spitting or spouting of water at other guests.
14. Showers must be taken before entering the pool.
15. Coast guard approved life vests are the only type of flotation device allowed in the pool. Arm floaties for small children may be used if under the supervision of an adult in the water.
16. Must listen to and respect the lifeguard(s) at all times.
17. No flips or back dives off of the pool deck, ladders, or stairways.
18. Borrowed equipment or toys from the pool deck must be returned to original place.
19. Delta Township and Waverly Schools are not responsible for lost or stolen items in the pool, locker rooms, or viewing deck.
20. No running in any part of the facility.

RELEASE AND WAIVER

I (We) hereby make this application for the use of the Delta Waverly Pool on the date and hours stated. I (We) also certify that the information on the application is true and I (We) have read and agree to abide by the rental policy pertaining to the use of the Delta Waverly Pool as adopted by the Township of Delta. I (We) also agree to the fee charged, and shall be personally responsible to see that the use of the facility is in accordance to the rental policy.

I (We) further agree to release, indemnify, defend and hold harmless the Charter Township of Delta, Waverly Schools, its officers, trustees, agents and employees from and against all loss or claims incurred (including costs and attorney fees) by reason of liability imposed upon the Charter Township of Delta, Waverly Schools, its officers, trustees, agents, and employees for damages because of bodily injury, including death at any time resulting therefrom, sustained by any person or persons or on account of damage to property, including loss of uses thereof arising out of use of the Delta Waverly Pool and/or in consequence of the performance of this application, whether such injuries to persons or damage to property is due or claimed to be due to negligence of the Charter Township of Delta Waverly Schools, its officers, trustees, agents and employees.
